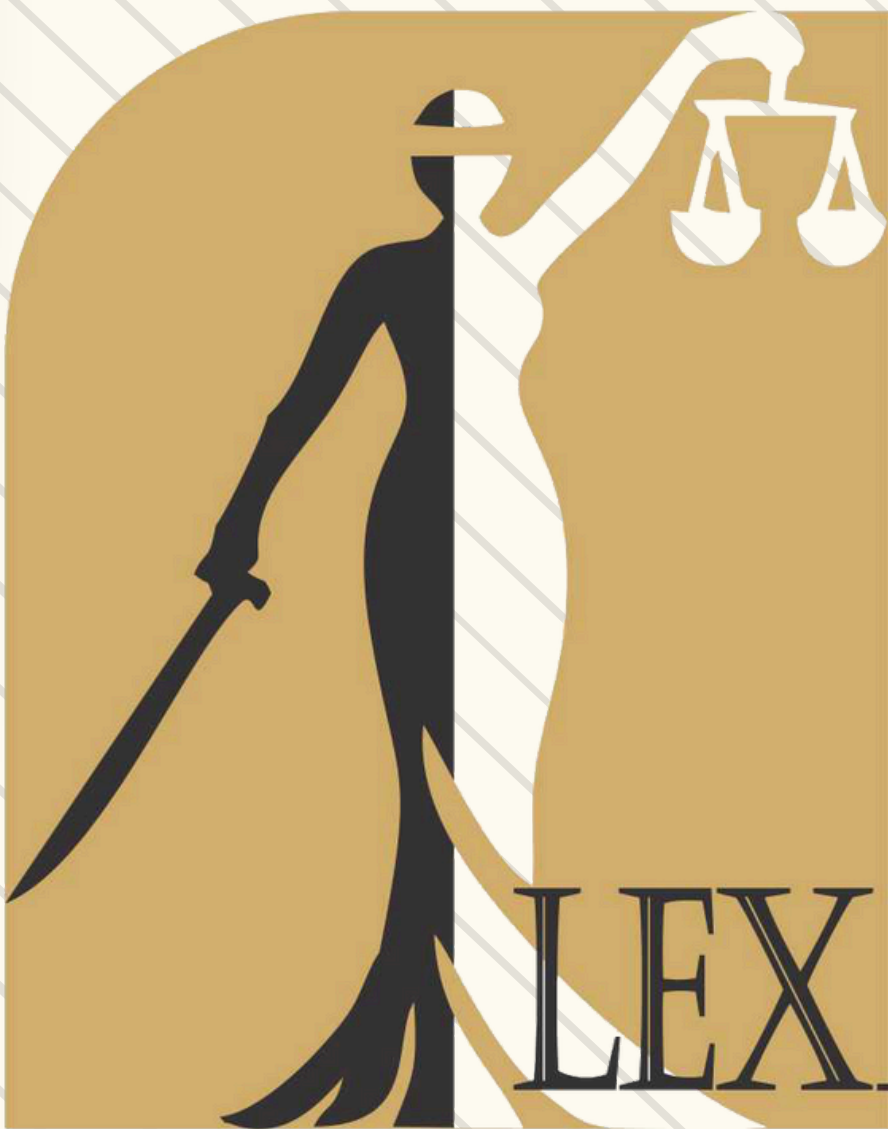

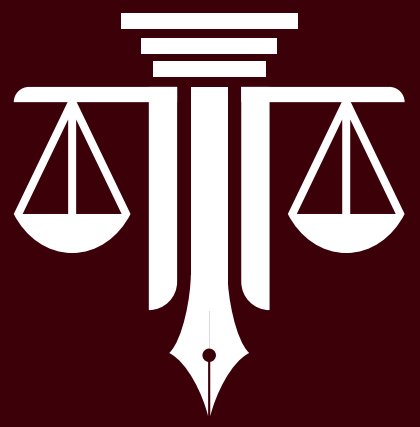

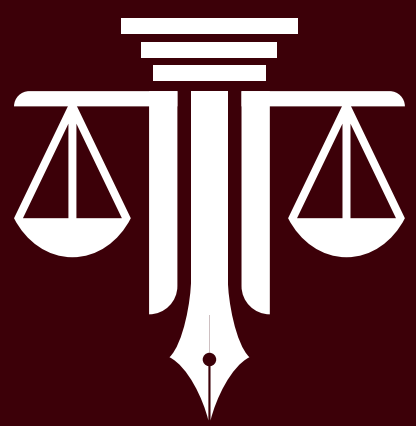
We don't look alike; we don't think alike; we don't come from the same place. Whoever you are, whatever you do, however you do it, TRCL is a place where your individuality flourishes.

TRIAL ADVOCACY

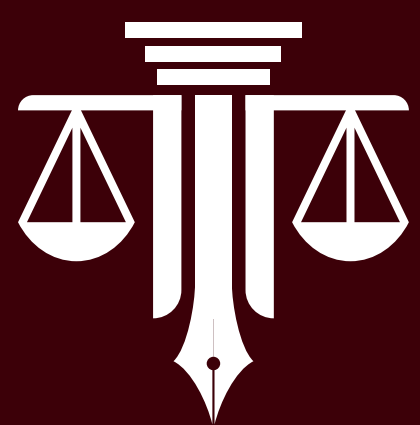

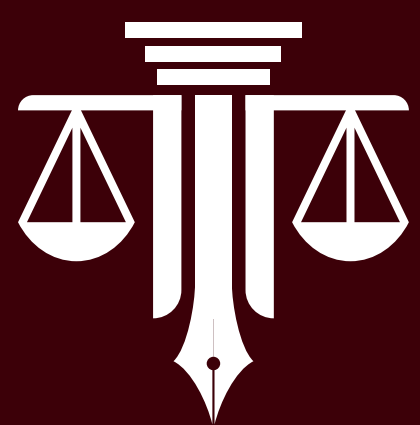
The registration process has been divided into 2 slots:

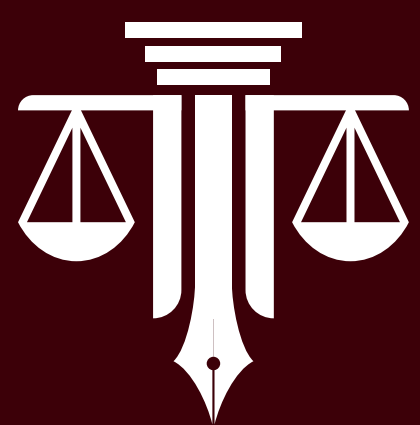
The registration fee shall be in the following format for each team:

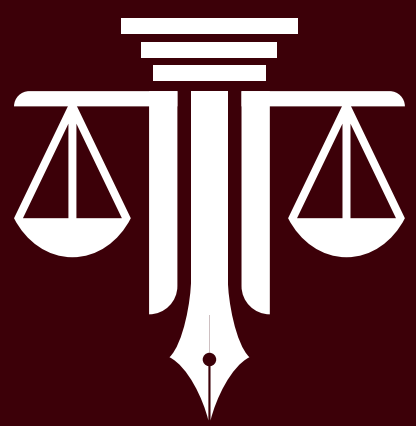
